Preference will be given to the local and previously disadvantaged service providers.

Only service providers registered in the Ulundi Municipality suppliers' database and registered with Central Supplier Database (CSD) will be considered.

Bid documents may be obtained on the **Ulundi Municipal Website at www.ulundi.gov.za**. Bid documents must be submitted in a sealed envelope clearly marked with the bid number, closing date and, dropped off in the tender box at SCMU, Ulundi Municipality, Corner of Princess Magogo and King Zwelithini Street, Ulundi, 3838 by no later **12H00 of the above stated closing dates**. The bid box is generally open from 07h30 to 16h30 Monday to Thursday and 07h30 to 15h15 Friday. All quotes must be submitted on the official forms – (Not to be retyped). This bid is subject to the general conditions of contract (GCC) and any other special conditions of contract.

THE FOLLOWING ARE MANDATORY: CSD summary report, valid tax clearance or SARS login pin, a certified copy of the most recent municipal account in which the business is registered, copies of ID of members of the entity, B-BBEE Certificate and Certified copy of CIPRO e.g. CK certificates. Bidders are requested to sign where necessary and initial each page on the Bid Documents.

This proposal will be evaluated in terms of the 80/20 Preferential Procurement Point system where 80 points are for functionality and price, and 20 points are for BBEE according to the said legislation.

Late tenders will not be accepted, and the Ulundi Municipality reserved the right not to make an award. Failure to comply with the above conditions will invalidate your offer.

Pre-qualification conditions for a tenderer (PPPFA) Act 2000: Exempted Micro Enterprise (EME) or Qualifying Small Enterprise (QSE) which is at least 51% owned by black people who are women and 51% owned by black people living in rural or underdeveloped areas or townships.

Kindly note that the successful bidder will be subjected to a screening process prior to the bid being awarded, should it be discovered that a successful bidder provided misleading information he/she will be disqualified with immediate effect.

SPECIFICATION

APPOINTMENT OF A SERVICE PROVIDER FOR ULUNDI MUNICIPALITY SPATIAL DEVELOPMENT FRAMEWORK

BACKGROUND AND TERMS OF REFERENCE

1. Background

- Ulundi Municipality prepared its SDF for 2022 – 2027 period and last made its review in 2021. The SDF covers most of the areas as legislatively required.
- There is a need to re-develop the SDF to further align with the current status, IDP, current legislation, Provincial and National priorities and programmes etc.

2. SLA and Project Work plan

- A Service Level Agreement (SLA) must be concluded between the Municipality and the successful bidder, which SLA will be drafted by the successful bidder and checked by the Municipality for compliance with its conditions, amended accordingly if necessary and signed by both parties.
- A project work-plan summary and detailed costing to be prepared by the consultant as a proposal and to form part of the SLA and inception report which will be evaluated by the Municipality and the Steering Committee.
- A Steering Committee for the Project will be formed, and members will be identified by both the Successful Bidder and Ulundi Municipality.
- It is important to note that no payment will be made in the absence of a signed SLA and/or outside the conditions in the SLA.

3. Legal Compliance

- The Procedure as outlined in the Local Government: Planning and Performance Management Regulations, 2001, should be followed to ensure legal compliance.
- Guidelines prepared by the Department of Co-operative Governance and Traditional Affairs should be utilized during the process and reference thereof be made.
- Spatial Planning and Land Use Management Act and Municipal By-law in this regard should be complied with fully.

4. Study area

- The SDF should accommodate the whole Ulundi Municipality Area of jurisdiction.
- Linkages between nodal points and Ulundi Town as well as that of neighboring Municipalities and Ulundi Municipality to be clearly identified.

5. Existing information

- The SDF review should take cognisance of the existing SDF document and related information and mostly alignment with the

the IDP Strategies and the LED plan is crucial.

6. Consultation

- Maximum consultation is expected with all role players. The ZDM, Zululand Development Planning Shared Services, Sector Departments, Traditional Councils and all neighboring Municipalities consultation is crucial.

6. Skills Transfer

- A successful bidder will be expected to work together with Ulundi Municipality Development Planning officials with the aim of capacitating the officials during the process and ensure that the Municipality will be left being able to review the SDF independently in future.

7. Final Product

The SDF should address the following issues:

- Present the desired future situation and other mapped information in a clear and legible manner.
- Present a Municipality's desired spatial form in various maps.
- Prepare Capital Investment Framework.
- Provide a framework for LUMS.
- Strategic assessment of the environmental impact of the SDF.
- Identification of programs and projects for land development.
- SDF to contain strategies and policies which provide strategic guidance in respect of the location and nature of development.
- Alignment of the SDF with the neighbouring Municipalities and the Zululand District Municipality.
- Alignment of SDF with spatial planning directives such as Provincial Spatial Economic Development Strategy and National Spatial Development Perspective.
- Consideration of the Provincial Development Guidelines.
- Delineation of the urban urge.

TAX CLEARANCE CERTIFICATE

1.5 Failure on the part of a bidder to submit a B-BBEE Verification Certificate from a Verification Agency accredited by the South African Accreditation System (SANAS or a sworn affidavit confirming annual turnover and level of black ownership in case of an EME and QSE together with the bid, will be interpreted to mean that preference points for B-BBEE status level of contribution are not claimed.

1.6 The purchaser reserves the right to require of a bidder, either before a bid is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the purchaser.

2. DEFINITIONS

- (a) **“B-BBEE”** means broad-based black economic empowerment as defined in section 1 of the Broad-Based Black Economic Empowerment Act;
- (b) **“B-BBEE status level of contributor”** means the B-BBEE status of an entity in terms of a code of good practice on black economic empowerment issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act;
- (c) **“black designated groups”** has the meaning assigned to it in the codes of good practice issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act;
- (d) **“black people”** has the meaning assigned to it in section 1 of the Broad-Based Black Economic Empowerment Act;
- (e) **“Broad-Based Black Economic Empowerment Act”** means the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
- (f) **“co-operative”** means a co-operative registered in terms of section 7 of the Cooperatives Act, 2005 (Act No. 14 of 2005);
- (g) **“designated group”** means:
 - 1. black designated groups;
 - 2. black people;
 - 3. women;
 - 4. people with disabilities; or
 - 5. small enterprises, as defined in section 1 of the National Small Enterprise Act, 1996 (Act No. 102 of 1996);
- (h) **“designated sector”** means a sector, sub-sector or industry or product designated in terms of regulation 8(1)(a);

5.1 In terms of Regulation 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded to a bidder for attaining the BBEE status level of contribution in accordance with the table below:

5.2 A bidder who qualifies as an EME in terms of the B-BBEE Act must submit a sworn affidavit confirming Annual Total Revenue and Level of Black Ownership.

5.3 A Bidder other than EME or QSE must submit their original and valid B-BBEE status level verification certificate or a certified copy thereof, substantiating their B-BBEE rating issued by a Verification Agency accredited by SANAS.

5.4 A trust, consortium or joint venture, will qualify for points for their B-BBEE status level as a legal entity, provided that the entity submits their B-BBEE status level certificate.

5.5 A trust, consortium or joint venture will qualify for points for their B-BBEE status level as an unincorporated entity, provided that the entity submits their consolidated B-BBEE scorecard as if they were a group structure and that such a consolidated B-BBEE scorecard is prepared for every separate bid.

- 5.6 Tertiary Institutions and Public Entities will be required to submit their B-BBEE status level certificates in terms of the specialized scorecard contained in the BBEE Codes of Good Practice.
- 5.7 A tenderer may not be awarded points for B-BBEE status level of contributor if the tender documents indicate that the tenderer intends subcontracting more than 25% of the value of the contract to any other person not qualifying for at least the points that the tenderer qualifies for, unless the intended subcontractor is an EME that has the capability to execute the subcontract.
- 5.7 The points scored by a tenderer for B-BBEE in terms of subregulation (2) must be added to the points scored for price under subregulation (1).
- 5.8 The points scored must be rounded off to the nearest two decimal places.
- 5.9 Subject to subregulation (9) and regulation 11, the contract must be awarded to the tenderer scoring the highest points.
- 5.10 (a) If the price offered by a tenderer scoring the highest points is not market related, the organ of state may not award the contract to that tenderer.
- (b) The organs of state may
 - (i) negotiate a market-related price with the tenderer scoring the highest points or cancel the tender;
 - (ii) if the tenderer does not agree to a market-related price, negotiate a market-related price with the tenderer scoring the second highest points or cancel the tender;
 - (iii) if the tenderer scoring the second highest points does not agree to a market-related price, negotiate a market-related price with the tenderer scoring the third highest points or cancel the tender.
- (c) If a market-related price is not agreed as envisaged in paragraph (b)(iii), the organ of state must cancel the tender.
